Valentine Vendor RULES & GUIDELINES

Thank you for your interest in participating in the **Valentine Maker's Market @ Annmarie**. The purpose of this event is to make locally grown and/or created items available to residents and visitors just in time for Valentine's Day. Preference will be given to vendors who create and sell items that lend themselves to the Valentine's Day holiday. Booth space in the **Valentine Maker's Market** is open on a first-come, first-served basis to vendors who grow or create products in the state of Maryland, including but not limited to, jewelry, arts and crafts, beauty products, candy, clothing, wine & beer, dairy products, native plants, home decor, etc. If it is homegrown, handmade, or homemade, it might be right for the **Valentine Marker's Market**! Buy Local!

Maker's Market Rules:

- 1. Advance Application Required Booth applications are accepted on a first come, first served basis until the Valentine Market is full. Please apply beforehand, do not drive in the day of the Market and expect to get a booth.
- 2. Booth Space we do not assign booth spaces, therefore, there is no guarantee you will get the booth space you want.
- 3. For the Valentine Marker's Market, ALL booths will be INDOORS. Space is EXTREMELY limited, so come ready to squeeze a lot into a small space. The booth fee includes one 8' table and one chair. We hope to give each vendor an 8' x 4' space. Bring your own display materials. You must transport, set up, and tear down your own booth.
- 4. **Cordial & Welcoming –** any vendor participating in an Annmarie event is expected to treat all visitors and staff with the utmost respect and consideration. We strive to create a warm and welcoming atmosphere for all visitors, regardless of age, race, religion, ability, gender, etc.
- 5. **Permits & Sales Tax** all Vendors must secure the proper state and/or county permit(s). All vendors are responsible for collecting and paying the required taxes.
- 6. The \$50 Booth fee is NON-refundable AND NON-transferable to another date (except in the event of a Calvert County determined weather emergency). There is a returned check fee of \$25.
- 7. **Please honor the spirit of the Valentine Market-** it should be appropriate for this special holiday and it must be homegrown, handmade, or homemade items produced or harvested by the Vendor.
- 8. **Maryland** All farm products must be grown or produced by the Vendor in Maryland. All processed foods and baked goods **must be prepared by the Vendor** from raw ingredients. The Vendor must be an active owner/operator of the business and may not operate under a franchise agreement. **No commercially manufactured finished products** will be permitted. **This isn't a flea market!**
- 9. Organic, recycled, reused, re-created, and/or native products are encouraged.
- 10. All products sold, or materials distributed, at the Market must be **family-friendly**. Any vendor selling products or distributing inappropriate materials will be immediately removed from the Market and banned from future participation.
- 11. Vendor set up time is Friday 3:00-5:00pm or Saturday 8:00-9:00am. Vendor must be present during Valentine Market hours, Saturday, February 6, 2016, 9am-2pm. Annmarie staff and volunteers cannot watch your booth or be responsible for your merchandise. Vendors who arrive before 3:00pm, will form an orderly line at the Admissions Desk.
- 12. Each vendor is responsible for **removing ALL their own trash**. This includes boxes, packaging materials, booth supplies and materials, crates, etc. In other words, anything you bring and don't sell (including cardboard boxes and misc. packing materials, you must take home! Any vendor who uses the Annmarie dumpster or leaves trash in their booth space will be fined \$25. Sorry, but trash removal service is very expensive.
- 13. Parking and admission to the Valentine Maker's Market is FREE.
- 14. If you have any questions or concerns, call the office at 410-326-4640 or email info@annmariegarden.org.
- 15. A special note about the MM and Artsfest: many vendors inquire about having a booth at the MM AND Artsfest. In an effort to clarify the difference, we offer the following info: the MM is intended to be a non-juried craft and farm market; Artsfest is a juried arts festival. It is our intention to keep them distinct. MM vendors are welcome to apply to Artsfest, but please note that the Artsfest jury will only accept up to 5 MM vendors each year.
